  - Is there any interest in revision to B&P 8773 to minimize information shown on a Corner Record?

*8773 (d) A corner record shall be limited to depiction of one (1) re-established corner with monumentation, one rehabilitated monument or one replaced monument. For the purposes of this section, reestablishment of a corner and monumentation shall be limited to “simple” methods such as single proportion, bearing/distance intersection, distance/distance intersection, or other tenable procedures from one or more found, verified original monuments. Multiple corner establishments using procedures requiring geometric methods such as rotations and translations shall be shown on a Record of Survey.*
