



## BACKGROUND

The Central Coast Chapter of the California Land Surveyors Association (Chapter) covers San Luis Obispo County and Northern Santa Barbara County. We were one of the original Chapters of the Association. The chapter only covers 3% of the state of California by area and only 1% of the population, yet this chapter has been a force in the Association since it's inception. The chapter has provided 5 Association Presidents, 3 Members of the Year and one "Dorothy Calegari" distinguished Service Award.

The Chapter currently has 53 members, broken down to 3 life members, 30 corporate, 8 associate, 9 affiliate, one student and 2 CE. The chapter has 6 business/program meetings each year, a summer barbeque and a Christmas potluck.

The chapter has never won the Chapter of the Year of the award, primarily as we have never submitted for Chapter of the Year. We, like most surveyors, are not the best at promoting ourselves.

It was suggested that based on our activities we should be proud and make the application for Chapter of the Year.

## TRIG\*STAR

## Background

With the exception of the Pandemic years, the Central Coast Chapter has run a Trig-Star program through many of our high schools since the 1980's. We have had a number of State champions come out of our chapter over the years and possibly one national champion. Our program has provided monetary prizes for the winner of each school and additional monetary prize for the chapter winner. These prizes along with free dinners for the winners, their family and teacher have been supported by local firms and individuals.

This year again we had a very successful Trig-Star being run by Luz Garcia. Luz coordinated with the schools, ran the tests for each school and then coordinated the awarding of prizes. The effort put into organizing this event is well beyond what should be expected from any volunteer in the chapter.

Due to scheduling the prizes were awarded at the summer barbecue, which turned out to be an excellent idea as the winners, their families and teachers got to meet with surveyors and their families in a causal atmosphere. Some of them even competed in the Surveyors Olympics at the barbecue.

## 2023 First Place Winner

The Chapter winner was Gwenyth Lemon from Paso Robles High School. Due to a previous commitment of heading off to school as a college freshman, Gwenyth was unable to attend the barbeque. Luz met with Gwenyth at the Paso Robles campus to present her with the trophy and award.

Gwenyth will be attending Colorado School of Mines studying chemical engineering. She really likes STEM and is excited to start college this fall! Her hobbies include playing basketball, snowboarding, hanging out with family and friends, and watching The Office!



## **Runner Ups!**

The second and third place winners were Jon Raj of San Luis Obispo High School and Anthony Williams of Paso Robles High school.

The awards were presented at the barbecue by George Marchenko, who organized Trig-Star for 20 years for the chapter, only stepping down 2 years ago. George provided the winners and the audience with some background on Trig-Star and then asked the winners some questions apropos to nothing, just to prepare them for life.

## Background

The chapter created a mailed-out newsletter "Parallax" in 1990 to inform the land surveying profession within the chapter about chapter meetings, events and news that impacted the profession. Parallax was mailed out to over 100 recipients until 2008. At that time the chapter kept the original newsletter format but emailed them out as a cost savings matter. At that time the chapter had created a simple web presence used mostly for officers and committees. It became clear over time that we needed to keep our members and others in the profession more current than just through the emailed newsletter.

In 2013 the web site was updated and revamped to be our "Newsletter". The idea was that we could put out information on the fly and keep members up to date on all news that affected us. Anyone who has worked on a website understands that is more of a task than those ads make it look like. It took a few years and finally a new editor to make it a success. We are lucky to have Doug Rion as our editor for the last 5 years, as he is the person most responsible for turning it around to a point where it is the primary source of information for all land surveyors within the chapter area.

## SUMMER BARBECUE

## Background

The Chapter has put on a summer barbecue since 1981 only missing the two years due to the pandemic. The barbecue has been coordinated, organized and cheffed by former state CLSA President Ken Fargen since it's inception.Ken, his family and staff have worked tirelessly providing a Santa Maria Style barbecue for all that attend the barbeque. Some years that means they are feeding over 100 people.

Besides the food, the barbecue has had other events, such as horseshoes and cornhole competitions and often has had vendors come to show their wares.



The Chapter has also always had door prizes with

vendors, survey firms and individuals donating hundreds of items each year.



## 2023 Barbecue

This year the barbeque was held on warm Saturday August 12, at Cuesta Park in San Luis Obispo from 11:00am to 3:00pm. There were 63 men, women and children enjoying the event. This year was even more special as we had some of the Trig-Star winners, their families and teachers attend the barbeque and receive their awards. The local surveyors made sure the Trig-Star people felt welcome and even encouraged them to join the "Surveyor Olympics".

Yes, the chapter put on a "Surveyor Olympics" this year for the first time since 2000. Kyle Huerth, Immediate Past President organize the Olympics and was very successful at getting most of the people to participate in the event. It was as rigorous as you would want an Olympics to be while enjoying a nice cold drink. Everyone who participated enjoyed it and some even did fairly well at some of the events. Besides the "Surveyors Olympics" there were door prizes and raffles. Doug Rion, Parallax Editor, again took on the onerous tasks of calling out the winners for the near 100 prizes!



## **CHAPTER COMMITTEES**

As with all chapters and associations, various committees are more active than other committees based on the current events surrounding the chapter. The committees listed here are the most active committees for 2023.

## **Professional Practices Committee**

This committee is headed by the President of the chapter based on our by-laws. The committee only responds to complaints sent to them either through private parties or local agencies. This year the committee has addressed 9 complaints, 4 that had been ongoing since 2022 and 5 new complaints. As the details of the complaint are private, for this application we are only providing a summary:

- 1 case has gone to the Board of Registration
- 2 cases have been closed with successful resolution.
- 1 case was dropped due to unresolved culpability.
- 1 case successfully had 5 monuments replaced.
- 4 cases are still in progress

## **Education Committee**

The Education committee was assigned 2 tasks this year and initiated 2 other tasks.

  - 2023 recipient Eduardo Flores (Cal Poly Pomona)

The Scholarships are run through the CLSA foundation each year

## GPS on Benchmarks Program

The Education committee has organized the local NGS "GPS on Benchmarks" program for the last three years, ending in September 30 as that was the date NGS terminated the program.

The committee worked with Caltrans District 5 surveyors and private firms to donate over 200 hours of volunteer time and perform 60 occupations on benchmarks. County Surveyor for San Luis Obispo County, Ed Reading, now retired processed all the data through the NGS website.



The Committee prepared detailed updated lists of needed occupations, KMZ files and an interactive map of benchmarks for the volunteers to use. We worked with Caltrans to ensure the benchmarks were flagged as either being within or outside of Caltrans R/W so there were no permit issues.

To be clear, 2023 was the least successful campaign as Caltrans Surveyors were working overtime on all the damage caused by the early storms in 2023 and private surveyors were overwhelmed with all the redevelopment going on.

## Get Kids into Survey Posters

The Committee looked into the "Get Kids into Survey" program and posters and was impressed by the concept and the effort being made by those running the program. The committee then worked with the Parallax Editor to promote that locally within the chapter. The committee provided information and links for members to use to get those posters into their children's classrooms.

## EDMI Baseline re-certification.

Years ago the Chapter worked with Caltrans and NGS to establish the Santa Maria CBL EDMI Baseline. The baseline has 5 monuments along the south levee of the river. Two members of the Committee went out to inspect the baseline this spring . Their inspection found all 5 monuments in good shape, however there had been clear evidence of some destruction along the levee due to the winter storms.

The inspection initiated contacting the current NGS advisor for California to discuss a re-certification of the baseline with the chapters help. The initial contact has been positive, but a date has not been set as of the date of this application.

## **Monument Conservation Committee**

This Committee was created at the end of 2022 and has become fully active in 2023. The purpose of the committee is to promote the conservation of survey monuments by:

- Developing and updating models for Plans, Specifications and Estimates (PS&E) to provide for inclusion of same in public and private construction plans,
- Creating and distributing information regarding monument conservation to the public and others,
- Engaging the public sector and public utilities in outreach and educational opportunities regarding monument conservation and PS&E inclusion in RFPs and RFQs.

Robert Reese has been working with Dana Caccamise, NGS advisor, on trying to make this happen. Dana is trying to coordinate with Caltrans for a training class. It may happen next year, but at this time everything is tentative.

#### Action Item(s):

Much like the success we have had with the fresh new officers of the chapter, the committees, at least this one, needs new ideas.

#### **SUBJECT**: ORDINANCE AMENDING THE PUBLIC WORKS DEPARTMENT SUBDIVISION MAP AND DOCUMENT REVIEW FEE SCHEDULE-SURVEYOR DIVISION

The Central Coast Chapter (CCC) of the California Land Surveyors Association (CLSA) would like you to consider the following issues before the first hearing, scheduled for the Board of Supervisors meeting on June 6, 2023. These items concern the no-cap, cost recovery measures for checking Records of Survey (RS) maps, prepared by Professional Land Surveyors lying within the City incorporated limits in Santa Barbara County.

• The Professional Land Surveyors' Act (PLSA), <u>Public Resource Code 8766 & 8766.5</u>, affords the County Surveyor the sole responsibility for RS examination. There is neither an incorporated/unincorporated provision nor any reason for an incorporated city to contribute to the County Surveyor's examination costs. *Cities have no statutory or actual need to participate in the costs*: the costs are borne by taxpayers and citizens and are subsidized because they are a public benefit.

• While the proposed examination fees are levied at the time of submittal of an RS map by a Professional Land Surveyor, these fees are ultimately levied on the persons for whom the surveys are conducted, that is, the public: citizens, residents, landowners, and taxpayers in Santa Barbara County. It is the public being charged, not the land surveyor community. The subsidy of the RS examination process benefits the public, not individual cities. Incorporated cities should not be burdened with any extra RS checking fees.

• It is entirely possible that the cost recovery measures for RS checking fees charged by the County Surveyor's Office could exceed the cost of surveys by a Professional Surveyor.

Our Chapter would like to go on record as firmly against the implementation of the exorbitant proposed examination fee structure. We recommend the Board decrease their incorporated City's examination fees to match the unincorporated areas of the County's fee. Should you, the Supervisors for Santa Barbara County, need further information, we would be pleased to assist.



# Does "GPS on Benchmarks" really matter to the Central Coast?

o the Chapter is in its third year of assisting in the nationwide program of "GPS on Benchmarks" being run by NGS. The Chapter has gained some notoriety for the work we have done both from private and Caltrans surveyors.

The effort has been limited to a relatively few surveyors within the chapter. It could be that many surveyors don't see any direct benefit to the whole "GPS on Benchmarks" idea. At first glance it doesn't seem like it would have any impact on boundary surveys, after all "Benchmark" is in the name. It really doesn't seem like it would benefit local topographic or construction surveying. Any control survey is going to be done by tying into some sort of City or National control anyway, so why bother?

It would be great to show some direct correlation where every hour spent on a benchmark would mean \$100 dollars more in your pocket. That's not going to happen. When you read what NGS says about the program, again it seems like it does not apply to local surveys. So why do it?

There is a valid argument that it does pertain to local surveys and surveyors. Once the Feds finally get out their new horizontal and vertical datums, there will be more emphasis on tying surveys to it as the new datums are solely based on GPS data. Also, by tying benchmarks to the datum through "GPS on Benchmarks" program, those benchmarks will have updated positions on the new datum and they will be a part of the passive update program NGS has promised. It is not implausible that specifications for work products will require surveys to be tied horizontally and vertically to passive control. It is also a fair assumption that in the not too distant future courts could accept positions of original monumentation based on previous surveys of the monument tied to the new or future datums.

# A MONUMENTAL QUESTION: Do you set MONUMENTS or MARKERS?

After a (successful) search for a 50-year-old marker on a very large parcel along the California coast, a discussion with my client prompted me to mull over some semantics that arose in our discussion. Perhaps, I thought, this might be of interest to our surveying community. It concerns the *things* we surveyors set as place identifiers, *physical objects* placed to mark infinitesimal points on the face of the earth, *places* to which we assiduously assign spatial addresses (coordinates) that have relative relationships with other such places. In particularly I'm referring to those physical marks that (purportedly) identify legal boundaries or rights of way. These *things* we call MONUMENTS.

We land surveyors are legally and solely entitled to be the setters of these MONUMENTS. I know because it says so in the California Professional Land Surveyors Act (PLSA), pretty close to the beginning of the code.

It is unlawful for any person to practice, offer to practice, or represent himself or herself, as a land surveyor in this state, or to set, reset, replace or remove any survey **monument** on land in which he or she has no legal interest, unless he or she has been licensed or specifically exempted from licensing under this chapter [emphasis added] (California Business and Professions Code §8725)

Also, the Nevada Revised Statutes (NRS) have a similar definition of land surveying and the privilege thereof.

A person who, in a private or public capacity, does or offers to do any one or more of the following practices land surveying:

...(c) Determines, by the use of the principles of land surveying, the position for any **monument** or reference point which marks a property line, boundary or corner, or sets, resets or replaces any such monument or reference point. *[emphasis added]* (Nevada Revised Statutes §625.040)

This thing called a MONUMENT is mentioned 36 times in the PLSA, and 25 times in the NRS, but not once with a definition of what this MONUMENT is or is supposed to be. Yes, it's qualities – durable, sufficient in number, etc. – are noted, but it is left to the land surveyor (or individual licensed to perform land surveying, or individual exempted therefrom) to determine what a MONUMENT is and to statutorily mark it with her or his assigned license number.

We also set *things* that are NOT representative of property corners or lot corners etc. These things we call CONTROL POINTS. They, too, have spatial addresses and positions relative to other such CONTROL POINTS that assist us in determining the location of MONUMENTS. I've noticed that sometimes these things we surveyors set called CORNER MONUMENTS and CONTROL POINTS look awfully similar, sometimes virtually indistinguishable. So why don't we set CORNER POINTS or CONTROL MONUMENTS? Maybe you do and I just don't know about it?

And here in California there is even a program called MONUMENT PRESERVATION that purports to support the *preservation* of "monuments"! Not only are CORNER MONUMENTS targets for preservation, but so are CONTROL POINTS when they rise to a certain importance. (Govt. Code §§27584-27585)

So... I have some questions.

1 What is a MONUMENT anyway, and what does it mean to a lay person when we tell them we set MONUMENTS at their property corners?

2 Why this distinction of species as to what is hammered into the ground, or scribed or set to mark a particular place?

3 What qualities raise a thing to a level worthy of the moniker "MONUMENT"?

Regarding question 1, perhaps Mr. Webster needs to jump in here.

Ah, there it is, right there at 6: a boundary or position marker.

For a while now I have been referring to such things in conversation with clients and other surveyors as MARKERS. It seems there is little question in the mind of lay persons that when I put a thing at their property corner, it is a MARKER – it MARKS the location. I may tell them it is a 2" iron pipe with a small brass tag on it with a secret code number, or it is a 1" domed brass disk in the sidewalk, or ... whatever. I have never had the label MARKER questioned or misunderstood. However, I have been queried by a client with a surprised look: "How big is the monument?". Thus the answer to question 1 above may be..."confusing?"

Question number two may be simply semantics – but only to us as a professional group. A CONTROL POINT is something that is not the other thing, a MONUMENT. OK, fair enough. The 1" iron pipe or No.5 rebar I set, both having a plastic cap with the notation "CONTROL POINT" along with my business name is simply not a MONUMENT. (Some may question why not my LS number? Reason to follow.) However, many times I have had to explain to a property owner that that colored plastic thing here that says "CONTROL POINT" is a CONTROL POINT, and that colored plastic thing over there with an LS number that someone else set is a MONUMENT, appearing to the uninitiated almost identical – plastic, about the same size, some bright color, with some writing on it. Perhaps the situation deserves reconsideration by our group.

And now to question number three. What makes a MARKER a MONUMENT? I have now arrived at the reason for this diatribe. We surveyors set all types of MARKERS: nails, nails with brass tags, bronze discs of varying diameter, stones, tree scribing, iron rods and pipes, car axles, the list is long. But my question is what do most people envision when they hear the word MONUMENT? Personally, I see the Washington Monument. I see the obelisks that mark the international border between the United States and Mexico. I see a number of markers of "lasting evidence of something notable or great". How do you see your surveys? Do you see them as something "notable and great", no matter how quotidian the endeavor is to you or how small the lot in the block? I submit that the property owner may attach more importance to your survey than you do.

As a case in point, and the incident that led to this writing, I offer this anecdote. I was retracing a survey done in 1970's by an individual licensed to perform land surveying services. His was a pretty important survey I thought, and covered a large, valuable and pristine tract described along a part of the California coast that has spectacular views. That survey set ½" rebar and plastic caps. I found said rebar, bent, buried, without the benefit of the identifying cap, but in the expected position and it clearly had the hallmarks of a piece of steel in the ground for nearly half a century. What does the landowner for whom the survey was performed think of such a non-durable marker, one that says "My survey effort is worth an 18" piece of ½" rebar and a cheap plastic cap set to mark the corners of your valuable land." Now, in counterpoint, I have had the honor of retracing one County Surveyor who, in the early 1900's cast his own (impressive) bronze disks, 4" in diameter, with the name of the client, his name and the date of the survey cast into the marker and set them in a 2" iron pipe, buried in the ground. Talk about lasting evidence of something "notable and great"!

Think about what you set as a MONUMENT, that MARKER that represents your survey work, the product of your professional expertise and experience. How proud are you of your survey effort? What will your client think of their new property marker? How much more effort is it to set, say, an iron pipe with a bronze disc in concrete (which could easily outlast your lifetime and be relied upon by those following in your footsteps) than a ½" rebar and plastic cap, one which can be bent or removed with slightest effort by natural forces or by man?

That, my fellow surveyors, is a MONUMENTAL question.

# How hard can it be?

I was lucky enough to attend the most recent chapter meeting in Los Osos, to hear Robert Reese's excellent presentation on hydrographic (bathymetric) surveys. Over the course of the presentation, he tried to infer how easy this work was, while showing, at least from my view, that it was fairly complicated.



I think he has a point, although he may disagree with me, that an experienced professional can be competent and successful in this area of surveying. However, his use of the Staples "Easy" button got me thinking about how people, like me, learn how to do some technical task. These days we use YouTube as a source, and I suspect that there are YouTubes on surveying.

However, that is really passe these days, you don't see any kids doing YouTubes. So I thought I should go to the source that people will be using to find out how to do their weekend surveying - A.I. Specifically I went to ChatGPT 3.5 July 2023 version. This is not GPT-4, which is supposed to be significantly better than 3.5 but also requires a monthly fee.

So, what follows is my discussion with ChatGPT about a boundary survey that your potential clients will be having. As you will see ChatGPT likes to talk.

# I need to do a boundary survey on a city lot, what equipment will I need to perform the survey?

In the field for this boundary survey, I found the two back corners, but could not find any front corners. I did find a monument in the centerline of the road on each side of my lot. How can I establish the front lot corners?


In conclusion, while it may be possible to conduct a basic boundary survey on your own for a simple and well-defined lot, it is generally advisable to involve a licensed

Well, I decided to do it on my own and file one of those record of surveys with the County Surveyor's office. What should I show on the map that I file with them. Do I need to show my house location, or just the monuments I set? If you have decided to conduct the boundary survey on your own and file a Record of Survey with the County Surveyor's office, it's essential to include accurate and relevant information on the map. While I can provide general guidance, keep in mind that specific requirements may vary depending on your local jurisdiction. Here are some key elements you should consider including on the map:

1. Property Boundaries: Clearly depict the property boundaries of your lot on the map. Use accurate measurements and angles to define the boundary lines.



2. Corner Monuments: Show the locations of the corner monuments you set during the field survey. Use symbols or labels to identify each corner, and include details about the type of monument used.

3. Lot Dimensions: Include the dimensions of the lot, indicating the lengths of each boundary and the angles between adjacent

sides.
